

We're Hiring: Farmers Market Specialist



Job Title: Market Specialist (Alexandria Farmers Market)

Reports to: Executive Director for Farm & Food.

Status & Pay: Salaried \$54,000/yr depending on experience, full-time,

exempt.

Benefits: Health Insurance, vision/dental insurance, HSA contributions, life insurance, generous and flexible vacation and sick-time, professional development opportunities.

Work Schedule: Monday - Friday, especially market days (Tuesdays) year-round. Some evening work is required. Some travel in-state and out of state on occasion.

Work locations/conditions: 1302 Murray Street Alexandria, LA (office) and 2727 Jackson St. Alexandria, LA (market), other locations as needed, work is outdoors in all weather conditions with repeated heavy lifting (50 lbs +), inside at a desk in an open office environment; year-round, some shifts may exceed 8 hours as needed.

Job Duration: This position is grant funded and continued employment is based on performance.

Job Summary: The Market Specialist role is ideally suited for someone who wants to learn how to run a farm or food business! Do you think like an entrepreneur? Are you willing to try things that will fail and keep moving forward on a project? Do you love to garden or farm? Have a passion for building equitable food access in central Louisiana? Do you want to support the sustainability of very small/small farms and help build a financially rewarding specialty crop industry in our state? Do you understand the basic concepts of fresh food aggregation (working with gardeners and very small farms) and enjoy connecting with customers about fresh fruits and vegetables? The Market Specialist, employed by Louisiana Central and working primarily with the Alexandria Farmers Market, will be responsible for the day to day operations of the Consignment Table at the Tuesday Alexandria Farmers Market. The Market Specialist is one of two Louisiana Central staff onsite at the market every Tuesday. They prepare the market location and equipment each week, set-up/ tear-down and oversee AFM sales and services at the consignment table. This position focuses on the general market operations, data collection, community engagement, and consignment table inventory and vendor management. onsite market staff are responsible for enforcing policies and assuring smooth and safe operations of the market every week. This is a physically demanding, public facing, outdoor job, and it requires the ability to move equipment weighing up to 50 lbs., step up and down out of/off of trailers, set up multiple 10'x10' canopies, move large boxes and provide first aid

in emergencies (once qualified). Working conditions include but are not limited to rain, heat, excessive humidity, freezing temperatures and wind; plus the occasional blue-bird day that makes all of that worthwhile. The person hired for this role must have a valid driver's license, proof of vehicle liability insurance, and a reliable vehicle to get to and from their duty stations daily.

Market Specialist Job Duties and Responsibilities Could Include:

- Efficiently perform market set-up, operations, and breakdown weekly in all weather conditions with the Vendor & Market Specialist.
- Coordinate vendor layout weekly and troubleshoot logistical issues in real time with the Vendor & Market Specialist.
- Onsite coordination of the Tuesday market, including the consignment table, in collaboration with the Vendor & Market Specialist.
- Establish and maintain the consignment table processes for produce delivery, aggregation, and close out weekly.
- Manage consignment table point of sale system, vendor invoicing, and inventory control measures.
- Communications: Facebook live events weekly, social media posts, stories, and outreach, send all-vendor email weekly, respond to social media messages, phone calls, and market business in a timely manner.
- Ensure vendor compliance with market rules and regulations, work with the Vendor & Market Specialist to build a culture of understanding and support for rules and regulations.
- Co-manage market data collection, recordkeeping, and vendor files in partnership with the Vendor & Market Specialist and the team administration assistant.
- Represent AFM in the community at large through relevant outreach activities.

Other duties as assigned and at the discretion of the Executive Director for Farm & Food.

Relevant Skills and Expertise Could Include:

- Small Business Management/startup.
- Specialty Crop small scale production agriculture.
- Familiarity and experience in produce postharvest handling, wholesale produce quality standards, regulatory compliance, and GHP/GAP/FSMA food safety regulations.

- Knowledge of and comfort with agriculture production, farms, farmers markets, and farmers.
- Experience selling to, buying from, and/or operating a food hub.
